#### TERMS & CONDITIONS FOR HIRING OF VEHICLES

The following terms and conditions must be fulfilled by the successful bidder for providing a vehicle on hire on monthly rent basis.

The hired vehicles during period of contact, shall have all necessary valid MV documents such as :- Valid registration certificate, Insurance Certificate, Fitness Certificate, Valid Contract Carriage Permit, proof of up to date tax payment etc. and D.L of the driver available all the times. The department/office hiring the vehicle shall not be responsible for any damage/loss caused to hired vehicles or loss of life/injury made to any person or damage to any property on account of use of hired vehicle any manner whatsoever. The hirer shall be responsible for all such litigation.

2 The service provider should have valid GST registration & GEM registration.

3. The hire charges to be paid for monthly basis is final and does not include cost of fuel (Diesel/Petrol) which is to be paid separately basing on actual consumption and lubricants as per existing Govt. norms. All the expenditure of the vehicle towards repair, replacement of spare parts, lubricating of oil of engine, Gear box and differential Coolant, Tyre& Tubes, Battery etc. will be borne by the bidder.

It shall be the responsibility of the bidder to provider a good driver and the salary of

the driver shall be borne by the owner.

In case of breakdown for reasons whatsoever the replacement of vehicle of the same

or better model shall be provided by the owner of the vehicle/ bidder.

6. - 12. The vehicle shall not be more than 3 years old from the initial registration and also in good running condition during the period of contract. Vehicles older than 5 years should be replaced by new vehicle by service provider.

If the services are found to be unsatisfactory. The client shall give one-month notice

and terminate the agreement.

14. In case the service provider intends to withdraw the services of the vehicle and terminate the agreement, it shall be mandatory upon him for grant one-month notice before such withdrawal of service and termination of the agreement.
